Wyndham Lakes Elementary School Drop Off and Pick Up Times

Gate Parking and Entrance by Non-Residents

Please be aware that parking is not Permitted in front of the entrance or exit gates at any time, especially now with the construction on Wyndham Lakes Boulevard. Several residents have complained about parents from Wyndham Lakes Elementary School using our front gate area to park their vehicles so they can avoid the drop off and pick up lines at the school. They are also tailgating residents into the community and parking inside as well. Residents and staff members of DWD Professional Management who have tried to talk to these

parents have been threatened and verbally assaulted. Many times the parents claim that they have permission from friends within your community to park at the gate or to enter through the gates and park inside. If this is the case, please inform your friends that this activity is not allowed. If your friends would like to enter the community by contacting you at the call box and then parking in your driveway, this would be acceptable since they would be your guest on your personal property. However, since the front gate area and the roads belong to the HOA, it is considered the Association's private property. All violators will be towed and/or trespassed. We greatly appreciate your cooperation in this matter.

Huntcliff Park Speed Limit

It has been observed that some of the residents and many visitors are driving way too fast in the community. The posted speed limit in the community is 20 miles per hour. There are many children playing in the neighborhood. For their safety, and the safety of all residents and guests, please keep your speed at or below the posted limit. Thank you.

Dog Waste

It has come to the Board's attention that many of the residents in your community are pet owners. Owning a pet is a wonderful experience for the "parent" and it brings many joys to as well. However, having a 4-legged addition to your family also brings many responsibilities.

If your new bundle of joy happens to be a dog, then one of the responsibilities is picking up after your pet. When you live in a community you cannot just let your dog out and then close the door. Your pet must be on a leash at all times, and any pet waste MUST be picked up and disposed of in a waste receptacle. Do NOT allow your pet to roam onto a neighbor's yard and do their business without picking it up. If your neighbor contacts Orange County Animal Control there may be fines involved for this violation. Thank you for your understanding.

Orange County Bulk Pick Up Instructions

Inder the Orange County Curbside Collection program, garbage, recycling, and yard waste are each picked up <u>only one time per</u> week.

Per the documents of your community, we are asking that you please do not place these carts outside your home in view from the street on days when you do not have a scheduled pick-up. Please keep them inside your garage, behind your fence, or behind your home.

In addition, if you have any large items that need to be picked up that will not fit in the new garbage bin, please contact the County to arrange pick-up. Do not place bulk items in the street or in your driveway. You must email or call the county at: <u>Solid.Waste@ocfl.net</u> (include your name, street address, contact information, and the item(s) that you want collected) or call the Solid Waste Hotline at 407-836-6601 to arrange for pickup. Large items include furniture, appliances, mattresses, automobile tires (limit 4), and rearprojection televisions. Limit large items to three cubic yards (about one small pickup truckload) household per week.

2. Don't stay out for too long.

If you live somewhere where it gets really hot, you should keep your plans for outdoor activities reasonably short. Don't plan to spend

INFORMATIONAL NOTICE

Wyndham Lakes Boulevard Emergency Sewer Repair

Orange County Utilities will be performing utility improvements on the gravity sewer and manholes along Wyndham Lakes Blvd. Construction will be within the County's right-of-way. The project includes approximately 108 feet of gravity sewer to be replaced, two manhole removals, and one new manhole. Due to the location near the school and extreme depth of the gravity lines and manholes, the maintenance of traffic has been coordinated with Wyndham Lakes Elementary School, and will include police assistance during school hours. Anticipated disruption to the community during construction will include partial road closure of Wyndham Lakes Blvd from Huntcliff Park Way and Wyndham Lakes Elementary School. Sidewalks will remain open for pedestrian foot traffic in the area. All disturbed areas (roads, sidewalks, medians, etc.) will be restored at the completion of the project. Construction is anticipated to begin in August 2017. There will be no cost to the residents or business owners. Please refer to the project location map and expected traffic pattern on the reverse side of this notice.

the whole day out in the sun – stick to a couple of hours and then head inside for a break. You don't always feel the effect the sun is having on you in the moment, but it can build to something dangerous if you're not careful to temper the time you spend outside on hot days.

3. Check the forecast before you go out.

You don't want to be caught unawares on a 104° day. Make sure you know what to expect of the weather before you go out so you can dress appropriately and plan your day accordingly. Don't risk being stuck on a hike far from your car when record temperatures hit in the afternoon. When the heat starts to get extreme, make sure your plans give you an easy out from the outdoors so you can take breaks and cool off.

4. Keep sunscreen where it's easily accessible and you'll remember to use it.

If you carry a purse, keep your sunscreen in it at all times. If you don't, stick some in your car or anywhere else you can think of where you're likely to have it when you need it. If you think you might forget to re-apply when needed, set yourself an alarm, pretty much all phones have that option these days.

5. Check the side effects of your prescriptions.

Some medications make people more sensitive to the sun. Make sure you know if your prescriptions mean you need to take extra precautions. It probably won't mean you have to forego outdoor activities, just that you'll need to make extra sure to follow some of the other suggestions on this list to avoid problems.

6. Use your air conditioning if you have it.

I know it costs money, but summer heat waves can have serious consequences for seniors. Making sure you're reasonably comfortable and safe in your own home is worth the splurge. If you don't have an air conditioner, consider buying one. The Low Income Home Energy Assistance Program may help if the cost is prohibitive.

If you don't have A/C in your home and can't find a way to afford it, take trips in the hottest part of the day to the mall, the movies, or the closest library. You can take advantage of their A/C for a little while before heading back home when the day starts to cool down.

7. Know the early warning signs of heat-related illnesses.

Hopefully these tips can help keep you from encountering a heat related illness, but you should still be prepared for the worst just in case. Review the symptoms for dehydration, heat stroke, heat exhaustion, and heat syncope here. If you suspect you're experiencing any of these, don't be shy about speaking up and insisting on water, shade, or some time inside in air conditioning. It's better than a trip to the emergency room.

INGREDIENTS

1 cup sea salt

2 cups baking soda

1 cup Epsom salts

1 to 2 tablespoons pure vegetable glycerin per bath (available from your local health food store)

4 to 6 drops essential oil per bath (lavender, sandalwood, or ylang ylang would be nice choices)

1. Combine the dry ingredients in a bowl, stirring to blend. Add 1/4 cup to your bath while the tub fills.

- 2. Add the glycerin to the bath to prevent drying (feel free to use less if your skin is oily, or more if your skin is dry) and the drops of essential oil.
- 3. The dry mixture will keep indefinitely in a glass jar with a screw lid. Makes 4 cups (enough for 16 baths).
